

Editorial

Time to Reshape the Digital Society

On **18-19 November** 2021, the **CRIDS** (Centre de recherche Information Droit et Société, Research Center Information Law and Society) celebrated its **40th anniversary** by organizing an **international conference** in Namur. The event was slightly delayed due to the Covid-19 health crisis. It gathered, in presence and online, many **speakers** and **participants** from all over the world. The conference's topic was obvious: "Time to Reshape the Digital Society".

Indeed, since **1979**, when the Centre was founded, the technological environment has significantly evolved. We learned that **Digital Society** is a truly "Two-Sided-Market". On the one side, some digital technologies are great tools, for our day-to-day lives, for businesses and for research purposes; but on the other side, these same technologies may also be used to commit crimes or threaten **democracy** and our fundamental rights. Therefore, in order to ensure the benefit of all and to be consistent with the **human values** we cherish, regulation of the Digital Society must be constantly rethought and this relying on the experience and knowledge gained over the past 40 years. The conclusion drawn at a CRIDS conference in 1983 is more than ever true: "*any new technology upsets the law. The latter has some difficulty in [apprehending and] taming the new fact, in informing it in its categories and concepts. This is what has happened with computers [and with] what is its very support and essence: information*".



Against this background, the **conference** elaborated an impressive number of proposals for future-proof shaping and regulation of the Digital Society. In the context of the editorial we can just identify two of them (a more complete set will be presented in one of the forthcoming issues of the RDTI Journal): at the brink of **digital technologies** and especially **AI** appearing to become ready to "take over", a self-determined use of such technologies requires skills, literacies and empowerment of all users of all ages. And, **Digital Society** needs consistent, coherent and sustainable **regulation**. To achieve this aim, with more than 30 European acts (from the Electronic Communications Code to the Data Governance Act) and an extremely high number of corresponding regulatory authorities (from the Data Protection Authority" to the "Digital Services Coordinator"), existing or in becoming, the keywords therefore can only be "**dialogue**" and "**cooperation**".

Finally: We would like to wish you all a **Merry Christmas** and a most excellent **New Year**. With regard to the legislative agenda on the Digital Society, it will certainly be fascinating.







Anne-Sophie LEMAIRE


